#### 1. GENERAL

The present safety plan concerns the 2025 Bridgestone FIA ecoRally Cup (China) scheduled for 23th-28th, Sep. 2025, at Anhui Province, China.

The present safety plan undertakes to respect the provisions, recommendations and requirements specified by local authorities (recommendations concerning the surveillance of the route and the intervention services). This notwithstanding, each organiser is permitted to add to this anything that might improve the safety of volunteers, competitors and officials, as well as the safety of the officials.

#### 2. INSURANCE

The organizer has contracted insurance covering the following risks: 15'561'000.- €

#### 2.2.1 Organizers' Liability Insurance

During the valid period of the insurance, if the insured causes personal injury, death or property loss to a third party due to negligence or fault in the process of organizing activities, and the economic compensation liability that should be borne by the insured according to the laws of the People's Republic of China, the insurer shall be responsible for compensation in accordance with the 2 stipulations of this additional insurance contract.

#### 2.2.2 Personal Accident Insurance



#### 8. SAFETY

#### 8.1. SAFETY OF THE VOLUNTEERS, COMPETITORS AND OFFICIALS

- A. <u>Details of where the rescue services are stationed (if any)</u> (On-site rescue service)
- B. <u>Instruction for intervention (in case of accidents, incidents and dangerous situations)</u>
  Definitions:
  - 1. Accident: An event involving personal injury, severe vehicle damage, or immobility of the vehicle.
  - 2. Incident: A situation that does not result in serious consequences but affects the progress of the event (e.g., a vehicle with minor breakdowns stopped within a stage, obstacles on the track).
  - 3. Dangerous Situation: A circumstance posing a potential threat to the safety of the event (e.g., spectators in hazardous locations, sudden weather changes, rockslides or fallen trees on the track).
  - 4. Universal Reporting Procedure
    Upon identifying any situation, personnel **must immediately** report to the Stage Director or Control
    Center via radio or satellite phone. The report must clearly convey the following information using
    the **CALM principle**:
  - **C Location:** Precise stage name and distance marker (e.g., RS3, 4.5km).
  - A Accident/Incident Type: Briefly describe what occurred (e.g., vehicle rollover, collision with a tree, fire).
  - L Injuries: Number of known: injured individuals and their general condition.
  - **M Manpower/Resources Needed:** Initial assessment of required rescue resources (e.g., medical assistance, crane, fire suppression).
  - C. The hospital(s) which has (have) been contacted and which would be used in the event of an emergency

(The local municipal hospital)



#### 9. INCIDENT PROCEDURES

#### 9.1. ON TRACK ITINERARY

#### → Minor incident

The medical emergency team is carrying out operations simultaneously, with minor injuries being treated on the site.

#### $\rightarrow$ Serious accident

The security team is controlling and managing the traffic; coordinating tow trucks to remove damaged vehicles and restore track access; while the medical team treatment to the injured.

#### 9.2. OFF TRACK ITINERARY

#### → Minor incident

In the paddock: The security team immediately guide the crowd for controlling the flow.

Involving spectators: None

#### → **Serious accident**

In the paddock:

Those with breathing difficulties received immediate airway management;

Individuals in cardiac problem received CPR;

Fracture cases were immobilized;

Ambulances were prioritized for critical patients to ensure hospital transfer within 30 minutes.

#### 9.3. MAJOR DISASTER PLAN

#### E.g Major explosion

The security team (firefighter team) extinguished the fire using suppression equipment, cut off the power supply, and conducted hazard inspections; meanwhile, the medical team provided first aid to those affected by electric shock.
